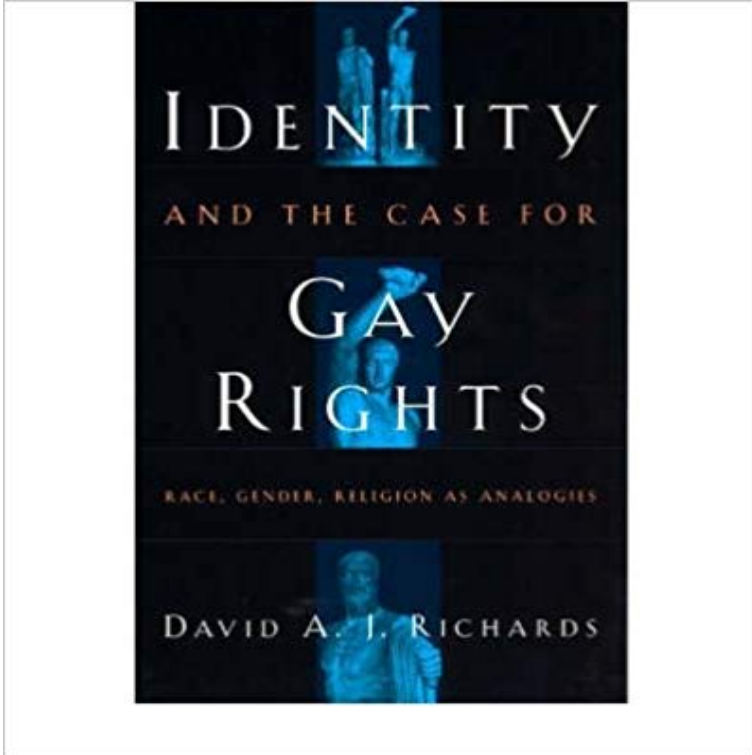


Identity and the Case for Gay Rights: Race, Gender, Religion as Analogies (Paperback) - Common
